AMBASSADOR (September to August)

1st Wednesday of the month from 8:30 to 9:30 a.m.

The Ambassador Committee is ideal for a member wishing to cultivate new business by welcoming new members to the Chamber, providing follow up with the member and participating in special events: *Member Orientations, Business of the Month, Biz After 5*, plus networking with members, new and old, who have not participated in Chamber activities in the past 6 to 8 months.

EVENTS (September to June)

3rd Tuesday of the month from 8:30 to 9:30 a.m.

The committee evaluates all events and programs with an eye towards change, renewal, additions and targeted networking. The committee addresses the education and information needs of local and regional businesses. It assists in the co-ordination and development of such activities as Business for Breakfast, Women In Business, Lunch & Learn, Curling Funspiel, Corporate Challenge. This Committee also includes a sub-committee (ENGEN) comprised of the next generation of young business leaders of the Chamber who plan 3 to 4 programs per year to engage the next generation in relevant activities that appeal to their interests, such as leadership, training, business networking and fellowship, which could include mentoring workshops, panels & events, mentoring luncheon, and Mix & Mingles.

FEDERAL PROVINCIAL MUNICIPAL AFFAIRS

(September to June)

2nd Thursday of the month from 8:30 a.m. to 9:30 a.m.

A Policy Committee and Task Forces monitor and interpret government legislation that will impact business and make recommendations for action to the Chamber of Commerce Board of Directors. The Committee and its Task Forces work with various levels of government and with the Economic Development Departments of the Greater Oshawa area to ensure the Chamber continues to be a strong “Voice of Business” on behalf of all members and that there is a climate for growth of existing businesses as well as new business.

ADHOC (Short Term Committees)

AWARDS (February to June)

2nd Tuesday of the month from 8:30 to 9:30 a.m.

Responsible for carrying out the nomination, interview and selection process for the Chamber's *Annual Business Excellence Awards*.

GOLF (January to May)

3rd Thursday of the month from Noon to 1:30 p.m.

Assists in the organizing of the Chamber's *Annual Golf Day*, by networking with members to explain the value of the Golf Day to their membership through hole sponsorships, golf cart sponsorships and silent auction prizes.

NOTE: All volunteers must be individuals employed by an organization that is a registered member of the Greater Oshawa Chamber of Commerce. *The President appoints all Committee members, subject to confirmation by the Board. All appointments are based on areas of expertise required, interest of the applicant and business affiliation so each committee is represented by a cross-section of the membership. Research indicates that the “ideal” committee should, in most situations, be 7 people, but this will vary according to the nature of the committee. Special Events such as the Business Excellence Awards or Golf Tournament may require involvement of more people.*
